- enhancing communication skills
- experiencing new technology
- self advocacy
- elder law
- emergency preparedness
- community integration
- developing community resources
- utilizing Support Service Providers (SSPs)
- leisure activity options
- sharing life experiences with others
- having FUN

**SSP: Support Service Provider**

We strongly encourage consumers to bring their own support service provider to assist them during the training. SSPs will be given free room and meals during the week. SSPs must provide their own transportation, and must share a room with their consumer. SSPs may be friends, family member, or a service provider.

Due to the intensity and one-to-one focus for many of the classes, we accept a total of six (6) participants in each program. Participants whose completed applications are received by the cut-off date will be given priority. You may request an application from your HKNC regional representative or admission's coordinator. We hope to see you either in the Spring or Fall of 2014.
