

# "Working as a Deaf-Hearing Team in the Legal Setting"

This two-part, 15-hour introductory workshop (Part One: 3 hours and Part Two: 12 hours) is for those who seek to advance their understanding and application of best practices while working as a member of a Deaf-hearing team.

Friday, August 19 <sup>th</sup> 6:00-9:00pm	We will cover the basic procedures that need to be in place for an efficient Deaf-hearing team in any setting within community interpreting, including legal.
Saturday, August 20 <sup>th</sup> 9:00am-5:00pm	The Deaf-hearing team in the legal setting, along with hands-on activities, will be the focus of the training on Saturday and Sunday.
Sunday, August 21 <sup>st</sup> 9:00am-3:00pm	Continued training from Saturday.

Participants will learn about legal interpreting, including the role and responsibilities of the legal interpreter in the courtroom setting, while working as a member of a Deaf-hearing interpreting team. Theory and <u>best</u> practices of the proceedings interpreter—and how that role is reflected in the application of protocol consistent with court procedure as a full Deaf-hearing interpreting team—will be discussed. Protocol relating to disclosures to the court, correcting the record, negotiating for optimal working conditions, and intra-team monitoring will also be addressed. Participants will engage in small and large group activities, at which time different protocol strategies will be discussed and applied.

His favorite settings are the two previously mentioned, as well as international sign and Deaf-blind where he has 23 and 10 years of experience, respectively.

Ryan Shephard from Oakland, California, is a Certified Deaf Interpreter, CLIP-R, with ties to the Deafblind community dating back to his last year in high school. He began his interpreting career as a Deafblind interpreter and continues to work extensively in that field.

Ryan has experience interpreting in other diverse settings as well, including conference, platform, legal, government, medical, and educational interpreting. Ryan has taught and presented on various interpreting topics, including several dynamic workshops focusing on the roles of CDIs and interpreting in legal settings. Currently, as an owner of Linguabee, a marketplace connecting consumers and interpreters directly, he is committed to making a difference in the communities he serves. Ryan is also an adjunct instructor at Ohlone College teaching interpreting courses.

While attending Gallaudet University, Mr. Shephard found his passion for interpreting and all that the career entails. During high school, Ryan was employed by a business owner who was Deaf-blind and it was there he was introduced to the Deaf-blind community. As a result of his becoming actively involved with and volunteering in the Deaf-blind community during his collegiate years, Mr. Shephard was awarded the Blaise Wafo Ndetatsin Award. He graduated Summa Cum Laude from Gallaudet University with a Bachelor of Arts degree in Interpretation.
